1. The tender documents are available in the O/o Sr. Manager (Civil), Mega Lift Project, Berhampur, Dist:-Ganjam from **04.02.2019 to 11.02.2019 Upto 12.00 Noon** on payment of Cost of tender document mentioned against each work. Or from the official website of OCC Ltd. "www.odishaconstruction.com" and can be downloaded from **Date 04.02.2019 to 11.02.2019 up to 12.00 Noon**. In such case, the Contractor has to deposit the cost of tender paper as above by demand draft to be drawn on or before Dt **11.02.2019** from any nationalized/scheduled bank payable at Berhampur in favour of M/s Odisha Construction Corporation Ltd along with the tender during submission .
2. The tenders must be accompanied with EMD (Earnest Money Deposit) of the amount specified for the work as mentioned in the above table in shape of Demand Draft drawn in favour of M/s Odisha Construction Corporation Ltd. Payable at Berhampur and should be valid for minimum 90(Ninety) days.
3. The tenders must be submitted in the O/o the Sr. Manager (Civil), Mega Lift Project, Berhampur, Dist:-Ganjam, on or before 1.30 PM of Date **11.02.2019** and will be opened **at 3.30PM** on the same day of receipt in the presence of the tenderers, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the tenders as specified above, the tender documents shall be received & opened on the next working day at the same time & venue.

4. Intending tenderers are required to furnish the following along with their tender.
 - a. Copy of up-to-date valid GST certificate.
 - b. Copy of valid labour licence.
 - c. Copy of valid enlistment certificate as Contractor/job worker issued by "OCCL".
 - d. Copy of EPF registration, if any.
 - e. Copy of PAN card.
5. The tender (sealed cover) must be mentioned on the envelope details of Tender Call Notice No, Date & Name of the Work clearly & delivered in the tender box kept in the O/o Sr. Manager (Civil), Mega Lift Project, Berhampur, Dist:-Ganjam. The sealed tender duly filled in properly must be signed by the Contractor in each & every page as a token of acceptance of terms, conditions, specifications as lay down in the tender.
6. **Additional Performance Security** shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Term Deposit Receipt pledged in favour of Odisha Construction Corporation Limited/ Bank Guarantee in favour of Odisha Construction Corporation Limited from any nationalized/scheduled bank in India counter guaranteed by its local branch at Berhampur within seven days of issue of Letter of Acceptance (LoA) by the Odisha Construction Corporation Limited (by email) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further proceedings for blacklisting shall be initiated against the bidder.
7. The Contractor shall have to furnish an affidavit in support of the authenticity/ genuineness of the documents/certificates and credentials along with the tender document. In case of production of forged document, the penalty shall be rejection of their tenders and cancellation of their enlistment with the Corporation. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.
8. The tender received will remain valid for 90 (Ninety) days from the last date of receipt of tenders and the validity of tenders can also be extended if agreed to by the tenderer and OCCL.
9. The Contractors shall have to execute work as per conditions of agreement & technical specification.
10. If any one bidder/Contractor participates in more than one work in this tender and becomes lowest in more than one works, he should have the qualifying criteria combinedly for all works, in which he becomes lowest. In such case, the authority reserves the right to award one or more work to them taking time factor into consideration.
11. The authority reserves the absolute right to accept or reject any or all tenders and to split up works to award to one or more Contractors without assigning any reason thereof.

12. Any dispute arising out of the above tender call notice shall be subject to Jurisdiction of Hon'ble High Court of Odisha at Cuttack.
