

1. On behalf of M/s Odisha Construction Corporation Ltd. ("OCCL"), the Senior Manager (Civil) Dhenkanal Group of Projects, Dhenkanal. invites sealed quotations/tenders from interested reputed Travel Agencies/Tour Operators or private individuals for providing 1no of Non AC/AC Diesel driven commercial vehicles (**preferably Bolero Plus/TUV-300/ Maruti Dzire**) on hire basis having sitting capacity not more than nine including driver, which shall confirm to the Terms and conditions (Annexure-II) for official use by the General Manager (Civil), Kanupur Spillway Project, OCC Ltd., Basudevpur, Keonjhar and Dhenkanal Group of Projects, Dhenkanal..
2.
  - a) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Certificates relating to Registration, Insurance, Permit, Fitness, Pollution etc. which are mandatory for plying of vehicle as per the state transport rules, which are to be furnished while submitting the quotation.
  - b) The Driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
  - c) The driver should be well behaved, gentle and obedient in nature.
  - d) A sum of Rs.5,000/- shall be deposited by the intending bidders in shape of Cash/ Bank Draft drawn in favour of Odisha Construction Corporation Ltd. payable at Dhenkanal and submitted along with the quotation as security deposit. After completion of quotation process, the amount will be refunded to unsuccessful bidders.
  - e) The monthly rate of hire charge to be quoted separately in the Annexure-III (excluding fuel and lubricants.)
  - f) The vehicle must achieve a fuel efficiency of 10 Kms per litre.
  - g) The details of requirement mentioned in Annexure-III are to be filled-up by the quotationer.
  - h) The quotation completed in all respect should reach the undersigned on or before dt. **23.03.2020** by **1.00 PM** and shall be opened on the same day at **3.30 PM** in presence of the bidders or their authorized representatives who like to remain present. If there will be a public holiday on the last date of receipt & opening of the quotations as specified above, the quotation document will be received & opened on the next working day at the same time and venue.
  - i) The application form of quotation containing General Bid Information & Terms and Conditions for hiring of vehicles etc. will be available with O/o the Senior Manager (Civil), Dhenkanal Group of Projects, Dhenkanal. on payment of Rs.100.00 + GST @ OGST 6% & CGST 6% = Rs.112.00.
  - j) The quotationers are requested to furnish the original documents during opening of quotations for verification.


