1. On behalf of M/s Odisha Construction Corporation Ltd. ("OCCL"), the Senior Manager (Civil), O.C.C. Ltd, Jajpur Group of Project, Jajpur invites sealed tender on lump sump contract basis from the eligible class of Job-worker enlisted with "OCCL" for following works.

The tender document can be obtained from **office of the Senior Manager (Civil), OCC Ltd., Jajpur Group of Projects, Plot No- 2546, Laliteswar Nagar, Jajpur** during office hour from **Dt 16.03.2020 to Dt 25.03.2020 up to 1.00 PM**. The bidder have to deposit the non refundable cost of tender paper specified for the work in the table as above in shape of Demand Draft from any Nationalized / Schedule bank operative in Odisha, payable at "**Jajpur town**" in favour of Odisha Construction Corporation Ltd. The Tender notice shall also be available on OCC Ltd. website at www.odishaconstruction.com. Interested Bidders may obtain further information, if any, from the undersigned.

3. The tender must be accompanied with EMD (Earnest Money Deposit) of the amount specified for the work in the table as above drawn in shape of Demand Draft from any Nationalized / Scheduled Bank operative in Odisha, payable at "Jajpur town" in favour of Odisha Construction Corporation Ltd. and should be valid for a minimum period of 90 (ninety) days from the date of tender call notice.

4. The tender to be received at the office of the Senior Manager (civil), OCC Ltd., Jajpur Group of Projects, Plot No- 2546, Laliteswar Nagar, Jajpur up to 02.00PM on dated **25.03.2020** and to be opened in the office of the Senior Manager (Civil), Jajpur group of projects, Jajpur at 03.30PM on same date in presence of bidders or their authorized representatives, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the tenders as specified above, the tender documents shall be received & opened on the next working day at the same time & venue.

5. Intending bidders are required to furnish the following documents duly signed by the bidder along with their tender.

- (i) Copy of up-to-date valid GST/ ITCC registration
- (ii) Copy of PAN card
- (iii) Copy of valid enlistment certificate as Bidder issued by "OCCL".
- (iv) Copy of EPF registration, if any.
- (v) Copy of No Relation certificate.
- (vi) E.M.D. in shape of D.D.
- (v) Affidavit in support of genuineness of certificate sl no. 8
- (vi) Affidavit of Indemnity Bond in DTCN
- (vii) Credential documents as per sl no. 10

6. The tender (sealed cover) must be super scribed - "**Tender Call Notice No. OCC/JGP/04 -2019-20 Dt. 16.03.2020**" and **Name of work** on the envelope clearly & dropped in the tender box kept in the Office of Senior Manager (Civil), OCC Ltd., Jajpur Group of Projects, Plot No- 2546, Laliteswar Nagar, Jajpur. The sealed tender document duly filled in properly must be signed by the Job-worker in each & every page with a token of acceptance of terms, conditions, specifications as laid down in the tender. All other credentials/documents submitted by the bidder along with this tender document must also be signed by him in each & every page.

7. **Additional performance Security** shall be deposited by the lowest bidder after finalization of tender. In such case, the lowest bidder shall be informed to deposit the differential amount i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of Demand Draft only in favour of the Odisha Construction Corporation Limited payable at Jajpur town within 7 days of receipt of letter from the competent authority **failing which the bid will be cancelled and the EMD amount shall be forfeited. In addition to the above, the bidder will be blacklisted.**

8. The bidder shall have to furnish an affidavit in support of the authenticity/ genuineness of the documents/certificates and credentials along with the tender document. In case of production of forged document, the penalty shall be rejection of their tender and cancellation of their enlistment with the Corporation. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.

9. The tender received will remain valid for 90 (Ninety) days from the date of receipt of tender and the validity of tender can also be extended if agreed to by the bidder and OCCL.

10. The eligible criteria for the Job-workers to participate in the above tender:

- a. The priority to be given the Bidders who have executed similar nature of work (septage treatment facility / building / landscape).
- b. The Bidder has to submit INDEMNITY BOND in stamp paper as per prescribed format provided in DTCN.

- c. The Bidder has to submit willingness letter from electrical license holder for execution of electrical work coming under this project.

11. The value of work mentioned is **excluding cost of cement and Steel and GST** (Goods and Service Tax). GST as applicable will be paid extra. The bidders are to quote the % (percentage) excess or less or at par of the amount put to tender in the bill of quantity in the format enclosed with the tender document. For evaluation, the amount quoted in words shall be taken, if there is any difference in figure and words in tender document. If the amount quoted by the bidder is **less than 15%** of the tendered amount then such a bid shall be rejected & the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted **at 14.99%** (Decimals up to two numbers will be taken for all practical purposes) less than the tendered cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders / their authorized representatives, the Senior Manager (Civil) / authorized person of Senior Manager (Civil) will remain present.

12. The bidder shall have to execute work as per approved drawing, Conditions of Contract & as per direction of client (OWSSB/PHD) from whom OCCL has been awarded with the work.


13. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in any Engineering Department of the State Government/Corporation is allowed to work as a Contractor for a period of two years after his retirement from Government Service/Corporation service, without Government/Corporation permission.

14. Joint venture is not allowed.

15. The authority reserves the absolute right to accept or reject any or all tender and to split up work to award one or more bidders without assigning any reason thereof.

16. Any dispute arising out of the above tender call notice shall be subject to Jurisdiction of Hon'ble High Court of Odisha at Cuttack and their sub-ordinate courts at Bhubaneswar only.


