2. All documents submitted as enclosures with this booklet must be signed by the applicant on each page and the **original documents** should be produced for verification at the time of submission of the application booklet.
3. **Money Receipt** towards cost of application form amounting to `1,000.00 (by hand) or `1,100.00 (by post), as the case may be, must be enclosed in original. The applicants applying for Grade C-IV/M-IV/ELT category should deposit the nonrefundable enlistment fees of `3,000.00 and attach the photocopy of the Money Receipt with the booklet.
4. The Corporation will intimate applicants applying for Grade III and above categories as well as Grade-EHT separately to **deposit the non-refundable enlistment fees** after provisional selection. After payment of the non-refundable enlistment fee, the applicant will be enlisted as a Job-Worker/Piece-Worker of O.C.C Ltd. which will be valid for a period of 3 years from the date of receipt of the application.
5. 3(Three) Nos. of recently taken **passport size colour photographs** duly **attested** by an Officer of Group - B or above of State/Central Government (at the backside) and **signed** by the applicant (on the front side) must be submitted along with application.
6. Income Tax PAN No., Sales Tax/VAT No., EPF Regn. No., Service Tax No., Affidavits for Ownership/Proprietorship in case of Company/Firm etc. must be enclosed with application booklet.
7. For Electrical Job-Workers, attested copies of valid **HT/LT License** issued by competent Authority such as Chief Electrical Inspector etc. along with other required documents must be submitted along with application.

For existing Enlisted Job-Workers applying for **Up-gradation** to a higher Grade, the same process of selection will be followed and the applicant is required to apply with this Application Form & Booklet. The applicant should also enclose a copy of Enlistment Certificate issued earlier by OCCL along with other documents as required for the grade applied for.
