- 4.5** Conditional tender shall not be accepted.
- 4.6** The Managing Director, OCCL, Bhubaneswar reserves the right to accept or reject any or all tenders without assigning any reason thereof.
- 4.7** The bid document shall form a part of contract and only required documents need to be uploaded during online bid submission for evaluation of bid.
