1. On behalf of Odisha Construction Corporation Ltd. ("OCCL"), the Senior Manager (Civil), Telengiri Spillway Project, Bariniput, Jeypore, Koraput invites sealed Quotation on item rate basis from the eligible class of Job Workers enlisted with "OCCL" for following works: -

2. The Quotation document can be obtained from office of the Senior Manager (Civil), OCC Ltd. Telengiri Spillway Project, Bariniput from 10.00 am of Dt.23.03.2021 to 31.03.2021 up to 1.00 P.M. The Quotationers have to deposit the cost of Quotation paper as above by non-refundable Demand Draft to be drawn on or after Dt.23.03.2021 from any nationalized / scheduled bank payable at Bariniput, Jeypore, Koraput in favour of Odisha Construction Corporation Ltd. during submission of the Quotation.

3. The Quotation must be accompanied with EMD (Earnest Money Deposit) amounting to Rs.4.00 Lakhs (Rupees four lakhs) only and should be valid for a minimum period of 90 (Ninety) days from the date of issue of this Quotation Call Notice in shape of A/C Payee Demand Draft in favour of "Odisha Construction Corporation Ltd." from any nationalized / scheduled bank payable at Bariniput, Jeypore, Koraput.

4. The Quotation (sealed cover) must be super scribed - "Quotation Call Notice No. 02/20-21; Dt. 23/03/21" - on the envelope clearly & dropped in the tender box kept in the Office of Senior Manager, Telengiri Spillway Project, Bariniput. The sealed quotation duly filled in properly must be signed by the Job-worker in each & every page as a token of acceptance of terms, conditions, specifications as laid down in the tender. All other credentials / documents submitted by the bidder along with this tender document must also be signed by him in each & every page.

The Quotation must be submitted at the Office of the Senior Manager (Civil), Telengiri Spillway Project Bariniput on or before 4.00 P.M on Dated. 31.03.2021 and will be opened on the same day and venue at 4.30 P.M in presence of the bidders or their authorized representatives, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the Quotation as specified

above, the tender documents shall be received & opened on the next working day at the same time & venue.

5. Intending bidders are required to furnish the following documents duly signed by the bidder along with their tender.

- a) Quotation paper Cost
- b) Earnest Money Deposit (EMD)
- c) Valid Enlistment Certificate (issued by OCCL)
- d) TIN No./Valid VAT clearance certificate (Form-612)
- e) PAN No. with photocopy of PAN card
- f) Affidavit regarding authenticity/genuineness of certificates.
- g) Undertaking regarding no relationship certificate.
- h) Copy of EPF registration, if any
- i) Copies of Credential certificates and documents required as per the relevant clauses of DTCN and special conditions if any.

6. **Additional Performance security** shall be furnished separately by the bidder when the amount quoted by the bidder is less than the value of the work put to quotation. The bidder has to deposit this additional performance security equal to the differential cost (Tender value minus quoted value) (upto the nearest thousand) drawn on any nationalized / scheduled bank in shape of demand draft in favour of Odisha Construction Corporation Ltd. Payable at Bhubaneswar **failing which the quotation will not be considered.**

7. The Job Workers shall have to furnish an **affidavit** in support of the authenticity/ genuineness of the documents/certificates and credentials submitted along with the Quotation document. In case of production of forged document, the penalty shall be rejection of their Quotations and cancellation of their enlistment with the Corporation. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.

8. The Quotation received will remain valid for 90 (Ninety) days from the last date of receipt of Quotations and the validity of Quotations can also be extended if agreed to by the Quotationer(s) and OCCL.

9. The Job Worker shall have to execute the work as per conditions of agreement & technical specification.

10. The authority reserves the right to accept or reject the Quotation and to split up the work to award to one or more Job Workers without assigning any reason thereof.

11. Any dispute arising out of the above Quotation call notice shall be subject to Jurisdiction of Honourable High Court, Odisha, Cuttack and their sub-ordinate courts at Bhubaneswar.
