Sealed quotations / tenders are invited from interested reputed Travel Agencies / Tour Operators or private individuals for providing having GST registration & GEM registration for providing 1 (One) No. of AC Diesel / Petrol driven vehicle TUV 300 / Bolero / SUMO Gold / Ertiga / Scorpio / Creta / Mahindra Marazzo / Innova or equivalent including driver, which shall conform to the Terms & Conditions (Annexure-II) for official use of the Senior Manager (Civil), Head Quarters Project, OCCL, Bhubaneswar.

- 1) The vehicle must be in Road Worthy condition, shall not be more than three (3) years old from the date of initial registration and must have valid Registration Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The driver of the vehicle must have valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs. 5000/- (Rupees Five thousand) only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the "Odisha Construction Corporation Ltd. – Project Account" payable at Bhubaneswar on any Nationalized Bank / Scheduled Bank and submit along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate Hire charge be quoted separately in the general bid information (excluding fuel and lubricants).
- 6) The vehicle must achieve a fuel efficiently of minimum average mileage in 10 Kms. Per litre.
