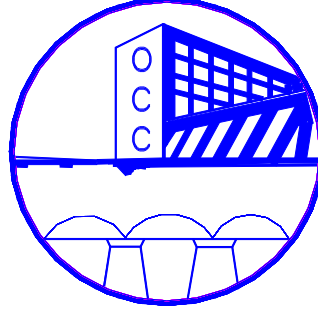

SCOPE OF WORK

1. The scope of OCCL shall be as under.

OCCL shall arrange

- (a) Electricity.
- (b) Angles, flats, J-hooks, L-hooks and painting materials as per requirement during the execution of work.

2. The scope of Job-worker shall be as follows:

- i) The Job-worker shall provide all required technical / non-technical / skilled / semiskilled / unskilled workmen as per requirement for execution of the project work.
- ii) The Job-worker shall provide scaffoldings and safety equipments for execution of the work with all safety measures for the crew during execution of project work at site at his own cost.
- iii) The Job-worker shall arrange all the amenities like, drinking water, rest sheds etc. for the workmen at site.
- iv) The Job-worker shall provide watch & ward arrangements for all the materials of Corporation and project materials at site at his cost.
- v) The Job-worker shall strictly adhere to the Covid-19 guide lines issued time to time by the Government of Odisha.

Decision of the Engineer-in-Charge regarding scope of work of the Job-worker shall be final and bindings on him. The Job-worker shall execute the items in the bill of quantities as per direction of Engineer-in-Charge or his authorized representative.

TERMS AND CONDITIONS

1. The quotationers should have been enlisted with OCCL and furnish certificate in support of execution of similar jobs with magnitude from Govt./ govt. firm and satisfactory completion thereof.
2. The quotationers shall have to furnish copies of GST registration certificate and PAN CARD.
3. No compensation is payable to the quotationers due to idle labour in course of execution of the work or supervision of the work due to rains, cyclone, floods and any other local problems etc.
4. The quotationers shall not engage workmen below 18 years of age and shall provide personal protective equipments (like helmet, shoe, safety glass, safety belt, nose mask, earplug etc.) as many required to all the workmen to be engaged as per safety rule.
5. All claims/liabilities etc. arising out of labour laws and also in case of injury/death of workmen resulting from accidents during execution of work shall be borne by the successful bidder.
6. The quotationers shall maintain the wages register/payment sheet and all other registers as required under labour laws that is presently in force and shall be personally responsible for violation of any of the provisions of the labour laws.
7. The quotationers shall process a valid license to engage labour at his own cost as per existing rules.
8. Payment towards price escalation/request for revision of rates is not admissible to the piecework till completion of the work.
9. 5% of the gross value of work will be deducted towards security deposit, which shall be released after six months of completion of work successfully & satisfactorily provided the final bill has been paid to the quotationers. Any defect found during the execution period will be rectified by the quotationers at his cost or will be adjusted against the security deposit in case the defect work is carried out by other agency. Other taxes & duties as applicable shall be deducted from the bills.
10. Payment: 100% payment shall be released after successful completion of the work in all respect after issue of final acceptance certificate by the Engineer-in-charge. However payment will be made as per actual measurement through R/A bill only duly certified by the site Engineer-in-charge.
11. Penalty: In case of failure to complete the work within the due date, or in case of non-performance/ poor performance, the contract shall be terminated within 07 days notice and the work shall be done by other agency of the cost and risk of quotationers.
12. The successful quotations should completed the work within the stipulated period i.e. **02 (Two) weeks** from the date of issue of Work order.
13. Any dispute arising out of this tender or order thereof is to be settled in proper court under the jurisdiction of Odisha High Court at Cuttack or courts under the jurisdiction of Odisha High Court at Bhubaneswar only.
