1. The materials in finished machined condition should be supplied by the successful quotationer/supplier as per sample and should strictly confirm to relevant standards of bureau of Indian /standards (BIS) as mentioned in tech. Specifications and price schedule.
2. The original test certificate of materials from a Govt./Govt. approved testing laboratory will be provided by the successful quotationer / supplier along with supply of materials. The purchaser is having the option to test the materials in any laboratory at the cost of the supplier and if the materials are not found in accordance with the specifications and grade in relevant Indian Standards, the materials will be rejected.
3. The materials will be guaranteed by the supplier against any defect for a period of 18 months from the date of supply or 12 months from the date of use, whichever is earlier. Guarantee certificate in this regard will accompany with supply of materials. If any defect is found in the materials within the guarantee period, the same will have to be replaced free of cost by the supplier.
4. The rate should be quoted by the quotationer on piece basis only. If the rate is quoted per unit weight or otherwise, the offer will be out rightly rejected.
5. The quotationer will quote their rates F.O.R. OCCL Store, Central Workshop, Rasulgarh, Bhubaneswar-10 (Odisha) indicating separately the basic price, packing, forwarding, transportation, transit insurance, handling charges, taxes, duties, levies etc. strictly in the specifications and price schedule format in original.
