Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing GST registration & GEM registration for providing 1 (one) no. of Non AC/AC Diesel driven vehicle TUV 300 / Bolero / sum Gold/ Ertiga / Scorpio / Creta/ Mahandra Marazzo / Innova, having sitting capacity not more than ten including driver, which shall conform to the Terms and Conditions (Annexure-II) for official use in the office of the Senior Manager(Civil), Head Quarters Project, Odisha Construction Corporation Ltd., Head Office, Bhubaneswar on monthly rent basis:

- 1) The vehicle must be in Road Worthy condition, shall not be more than three(3) years old from the date of initial registration and must have valid Registration Certificate, PUC Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The driver of the vehicle must have valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs. 5000/- (Rupees Five thousand) shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of "Odisha Construction Corporation Ltd." payable at Bhubaneswar on any nationalized Bank / Scheduled bank and submitted along with the tender as security deposit. After completion of tender process, the amount will be refund to unsuccessful bidders.
- 5) The monthly rate Hire charge be quoted separately in the general bid information (excluding fuel and lubricants).
- 6) The vehicle must achieve a fuel efficiency of minimum average mileage in 10 Kms. Per liter.
- 7) The details of make and year of manufacture of the vehicle, registration no., mileage (Kms. covered per liter) and the name of the driver with Driving License No. and period of validity should be specifically provided in general bid information to be furnished with Quotation (Annexure-II).
