ACETYLENE GASES & INDUSTRIAL GASES REQUIRED FOR CENTRAL WORKSHOP, RASULGARH, BHUBANESWAR”** and also date of opening of Tender. The name and address of the Tenderer should not be written on outer cover. Only the name and address of the purchaser should be written on the outer cover.
2. The offer should contain the following copies:
  - i. Valid GST Regn. certificate.
  - ii. Attested copy of PAN Card.
  - iii. Attested copies of purchase orders, credentials, certificates etc. in support of supply of similar items of magnitude and satisfactory performance thereof.
  - iv. The original terms & conditions, price schedule duly signed by the Tenderer, without which their offer will not be considered .
3. The Tenderer will quote their rates F.O.R. 10. The supply of gas should be made in phased manner as per our requirement.
11. No detention charges for cylinders will be paid under any circumstances for a period of 01 (One) month from the date of delivery of the particular cylinder / cylinders.
12. 100% payment will be released within 30 days against receipt of bill and other required documents after delivery & acceptance at OCCL Store.
13. In the event of any variation occurs due to hike in price of calcium carbide, enhancement of rate in DA Gas & Industrial Gas will be considered only on receipt of satisfactory documentary evidence.
14. Purchase order may be cancelled in case any material is found defective and not replaced by the Tenderer within a suitable time fixed by the Corporation without any extra cost. In this connection, the decision of the purchaser is final and binding on the Tenderer.
14. Price escalation will not be allowed under any other circumstances except Sl. No.13. The quoted rates will remain firm till execution of the purchase order.

In case of any delay in supply of material beyond the delivery schedule whatever may be the reason, supplier shall be liable to pay L.D. @ 0.5% (Half percent) of the total order value per week of delay or part thereof subject to a maximum of 5% (Five percent) of the total order value. Thereafter, the order may be cancelled with the discretion of the purchaser.
