The test certificate of the couplings shall also be provided from a Govt. / govt. approved test laboratory along with supply of couplings. The purchaser is having the option to test the materials in any laboratory at the cost of the supplier and if the materials are not found in accordance with the specifications, the materials will be rejected. Balance 10% payment will be released after 18 months of supply or 12 months from the date of commissioning whichever is earlier. - 18. Price escalation will not be allowed under any circumstances. The quoted rates shall remain firm till execution of the work order.
