**TERMS AND CONDITIONS OF TENDER FOR

1. Reputed manufacturers or their authorized dealers having supplied similar items of similar magnitude earlier and satisfactorily accepted by the clients will be eligible to participate in the tender. The copies of purchase orders, credentials, certificates etc. in support of similar supply and satisfactory performance thereof will be furnished along with the tender.
2. The tenderer should furnish technical literature, catalogues, drawing etc. showing all dimensions and details in support of specifications of machines & equipments quoted by them.
3. Tender should be submitted in two bid system in two separate sealed covers and both will be submitted in a single sealed outer cover subscribing in bold letters as **“SUPPLY OF AIR PLASMA CUTTING MACHINE WITH PUG CUTTING ATTACHMENT FOR CENTRAL WORKSHOP, RASULGARH, BHUBANESWAR-10”** and also date of opening of tender. 9. The first envelope will be opened on **03.02.2021** at **04.00 PM** first. Then the documents in the first envelope submitted by the tenderers will be scrutinized preliminarily on the spot. The second envelope of the valid eligible tenders after preliminary scrutiny of the documents in the first envelope will be opened on the same day immediately subject to fulfilling the requirements mentioned in the tender schedule.
10. Manufacturer's test certificate shall be provided by the successful tenderer along with supply of machines & equipments completed with all accessories. Inspection and testing of the components shall be made by the purchaser's representative before dispatch. The cost of testing and facilities for testing shall be borne / provided by the tenderer without any extra financial burden / claim on the purchaser.
11. Pre-delivery inspection (P.D.I) before dispatch of the machines & equipments will be made at the manufacturer's works by the authorized representative of the purchaser for which the manufacturer should intimate in writing for P.D.I. 10 days in advance regarding readiness of materials.
12. The machines & equipments with its accessories will be guaranteed against any defect/ bad works for a period of 12 months from the date of installation, testing & commissioning or 18 months from date of supply whichever is earlier. Guarantee certificate in this regard will accompany with supply. In case of any defects found within the guarantee period, the same will have to be replaced free of cost by the supplier.
13. The successful tenderer will have to furnish a performance bank guarantee (B.G) for 10% value within 30 days from the date of issue of purchase order. The performance bank guarantee should be valid for a period of 12 months from the date of commissioning and shall be released after completion of the guarantee period.
14. The purchaser reserves the right to forfeit and encash the performance bank guarantee in full in case any item is found defective and not replaced by the tenderer/supplier within a suitable time fixed by the purchaser.

15. The tenderer will quote their rates F.O.R. OCCL, Central Workshop, Rasulgarh, Bhubaneswar (Odisha) inclusive of packing, forwarding, transportation, transit insurance, handling charges, unloading charges, installation, testing and commissioning of the machines & equipments strictly in the price schedule format in original. 16. The tenderer should quote appropriate taxes with the offer.
17. The offer of the tenderer will not be considered, if their rates are not quoted F.O.R. OCCL, Central Workshop, Rasulgarh, Bhubaneswar (Odisha).
18. The rates and amounts should be quoted both in figures and words in the price schedule format. Any correction or overwriting in the specification and price schedule should be duly certified by the tenderer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered. In case of any mismatch in rates and amount, the rate will be considered.
19. 90% payment will be made within 30 (Thirty) days after supply in full, satisfactory installation, testing & commissioning of the machines & equipments along with bill, test certificate, guarantee certificate and other documents, subject to receipt of satisfactory completion report from the Engineer-in-Charge. Balance 10% shall be released within 60 (sixty) days against receipt of performance bank guarantee for 10% cost valid for a period of 18 months from the date of satisfactory commissioning. In absence of Bank Guarantee, balance 10% shall be released after 18 months of commissioning & satisfactory operation of the machines & equipments.
20. Price escalation will not be allowed under any circumstances. The quoted rates should be firm till execution of the entire work.
21. The validity of the offer should be for a period of 120 days from the date of opening of the bid.
22. The machines & equipments with accessories completed in every respect should be supplied, installed & commissioned successfully by the tenderer within 60 (Sixty) days from the date of issue of the purchase order, failing which the order is liable for cancellation without assigning any reason thereof by the purchaser. In case of any delay in supply of material beyond the delivery schedule whatever may be the reason, supplier shall be liable to pay L.D. @ 0.5% (Half percent) of the total order value per week of delay or part thereof subject to a maximum of 5% (Five percent) of the total order value. Thereafter the purchase order will be cancelled with the discretion of purchaser
23. After submission of tender and before placing order, the bidder may be asked by the undersigned to attend techno-commercial discussions and reply to queries within a specified period. If the bidder fail to do so, the tender submitted by the bidder is liable to be cancelled.
