SCOPE OF WORK.

Scope of work under this Quotation to be executed by the successful bidder are as under.

There are different types of M.S stem rods (IS:2062) on which square thread cutting with different lengths are required to be done to match with the nuts.

Scope of OCCL shall be as follows:

1. OCCL shall provide the stem rods with finished diameter 80, 63 & 50mm Dia to the successful bidder, in phased manner, at Central Workshop, Rasulgarh
2. The required nut/ nut assembled with the worm gear shall be provided by OCCL at Central Workshop, Rasulgarh for required thread cutting to match with same.

Scope of Successful bidder to be as follows.

1. He shall take delivery of the required stem and nut/ nut assembled with the worm gear from Central Workshop, Rasulgarh.
2. He shall bear the loading & unloading charges of stems and finished materials at different points of operations.
3. He shall transport all the required materials from Central Workshop, Rasulgarh to his workshop & deliver the same at Central Workshop, Rasulgarh after machining operation and the cost shall be borne by him .
4. All handling equipments and consumables required for the work shall be borne by the successful bidder.
5. The items listed in the BOQ are only indicative and there may be deletion & addition of the items as per requirement of OCCL.
6. Decision of the Engineer-in-Charge of the work of OCCL regarding the scope of work shall be final and binding on the successful bidder.

1. 80, 63 & 50mm Φ M.S. round of IS: 2062 in different length as per price schedule shall be provided by OCC Ltd, at Central Workshop, Rasulgarh, Bhubaneswar-10 for making square thread type (SQ 78 X 10), (SQ 62 X 9) & (SQ 48 X 8), No of starts for thread 2 (Two) for 80mm & No of starts for thread 1(One) against 63mm Φ & 50mm Φ respectively shall be received at OCCL Store, CWS, Rasulgarh, Bhubaneswar-10.
2. Bank guarantee for the cost of material to be handed over by the successful bidder. The successful bidder shall have to deposit Bank guarantee with OCCL for the cost of material to be provided by OCCL before taking delivery of the same to carry out machining at their workshop. The Bank guarantee shall be released after delivery of the finished materials at Central Workshop, Rasulgarh.
3. The quotationers shall quote their rates in the price schedule format in original per mtr. basis only inclusive of all charges for transportation, handling etc. The rates and amount shall be quoted both in figures and words.
4. The offer shall be valid for a period of 120 days from the date of opening of the quotation.
5. Price escalation will not be allowed under any circumstances. The quoted rates shall be firm till execution of the entire order.
6. Delivery of stem screw rod with complete threading as per specification shall be made within 60 (sixty) days from the date of receipt of the base materials from OCCL Store. Consignee of material will be Manager (Mech.), Store, Central Workshop, Rasulgarh, Bhubaneswar-10
7. 100% payment shall be made after receipt of stem screw rod in complete shape & in full quantity at our OCCL Store subject to verification of suitability and receipt of proper test and guarantee certificate.
8. Conditional quotations with deviations shall not be accepted.
