The test certificate of the couplings shall also be provided from a Govt. / govt. approved test laboratory along with supply of couplings. The purchaser is having the option to test the materials in any laboratory at the cost of the supplier and if the materials are not found in accordance with the specifications, the materials will be rejected. The half gear half rigid coupling shall be inspected by the authorized representative of the purchaser / client / third party appointed by OCCL. In case of any defect noticed during the guarantee period the same shall be replaced / rectified immediately by the manufacturer free of cost.

- 16. The rates and amounts should be quoted both in figures and words in the price schedule. Any correction or overwriting in the specification and price schedule should be duly certified by the tenderer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered. In case of any mismatch in rates and amount, the rate will be considered.

Balance 10% payment will be released after 18 months of supply or 12 months from the date of commissioning whichever is earlier.
