Bid will be opened on at 3.30 PM in the same venue in presence of the tenderers or their authorized representatives, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the tenders as specified above, the tender documents shall be received & opened on the next working day at the same time & venue.
- 6. Additional Performance Security shall be submitted by the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish an amount as stipulated below towards Additional Performance Security (APS) in shape of Demand Draft in favour of Ödisha Construction Corporation Ltd." payable at Bhubaneswar / Term Deposit Receipt in prescribed in favour of Odisha Construction Corporation Limited/ Bank Guarantee Limited from any nationalized/scheduled bank in India counter guaranteed by its by Odisha Construction Corporation Limited (by email) to the successful bidder
