- i) OCCL will transport 20 Ton capacity monorail crane hoist and accessories (01 set)
 to the Project site
- ii) OCCL provide electricity at one point at Project site.
- iii) OCCL shall supervise the erection of monorail hoist (20T)

2. The scope of Job-worker shall be as follows:

- The unloading of monorail crane hoist and accessories will be done by the Jobworker.
- ii) The erection of monorail crane hoist and accessories will be done by the Jobworker.
- iii) The Job-worker shall provide suitable capacity of crane for unloading and erection of monorail hoist and accessories.
- iv) The Job-worker shall provide all required technical / non-technical / skilled / semiskilled / unskilled workmen as per requirement for execution of the project work.
- v) The Job-Worker will supply all Tools & tackles required, machinery/equipments like, welding machine, suitable capacity Chain Pulley blocks, gas cutting set etc. for material handling and disposal with required machine, vehicle & manpower required to complete the work.
- vi) The Job-worker shall provide scaffoldings and safety equipments for execution of the work with all safety measures for the crew during execution of project work at site at his own cost.
- vii) The Job-worker shall arrange all the amenities like, drinking water, rest sheds etc. for the workmen at site.
- viii) The Job-worker shall provide watch & ward arrangements for all the materials of Corporation and project materials at site at his cost.
- ix) The Job-worker shall strictly adhere to the Covid-19 guide lines issued time to time by the Government of Odisha.

Decision of the Engineer-in-Charge regarding scope of work of the Jobworker shall be final and bindings on him. The Job-worker shall execute the items in the bill of quantities as per direction of Engineer-in-Charge or his authorized representative.

TERMS AND CONDITIONS

- 8. Payment towards price escalation / request for revision of rates is not admissible to the piecework till completion of the work.
