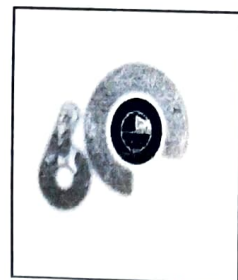

SPT should be conducted staring from 3.00 m depth in each 1.5 m alternate depth.
2. The participants should submit separate quotation for each work.
3. The price to be quoted should be inclusive of sampling & carriage cost. The rate should be mentioned up to two decimal only both in word & figure.
4. The quotation shall remain valid for a period of not less than 90 Days.


