- 9. The stainless steel flats should be supplied by successful tenderer / supplier strictly confirming to I.S. specifications as per required thickness, width of multiple length. However, the minimum length should not be less than 2.0 Mtr.
- 11. The original test certificate of materials from the manufacturer/ Govt. / Govt. approved testing laboratory will be provided by the successful tenderer along with supply of materials. The purchaser is having the option to test the materials in any laboratory at the cost of the supplier and if the materials are not found in accordance with the specifications and grade in relevant Indian Standards, the materials will be rejected.
- 12. The materials will be guaranteed by the supplier against any defect for a period of 18 months from the date of supply or 12 months from the date of use, whichever is earlier. Guarantee certificate in this regard will accompany with supply of materials. If any defect is found in the materials within the guarantee period, the same will have to be replaced free of cost by the supplier.
- 13. If the undersigned desires, pre-delivery inspection (P.D.I) before dispatch of the materials will be made at the manufacturer's works by the authorized representative of the purchaser/ client / third party for which the manufacturer should intimate in writing for P.D.I. 10 days in advance regarding readiness for P.D.I.

- 14. The tenderer will quote their rates F.O.R. OCCL Store, Central Workshop, Rasulgarh, Bhubaneswar indicating separately the basic price, packing, forwarding, transportation, transit insurance, handling charges, weighment, unloading, taxes, duties, levies etc. strictly in the detailed specifications and price schedule format in original. All columns and lines of the price schedule should be filled in properly without leaving anything blank. The details and rates of duties and taxes should be indicated clearly in the price schedule.
- 15. The tenderer should quote appropriate GST with the offer.
- 16. The rates and amounts should be quoted both in figures and words in the price schedule. Any correction or overwriting in the specification and price schedule should be duly certified by the tenderer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered. In case of any mismatch in rates and amount, the rate will be considered.
- 17. The rate of stainless steel flats should be quoted by the tenderer on Metric Ton (MT) basis only. The Stainless steel flat should be supplied by the successful tenderer as per required size, section, length and quantity as mentioned in detailed specification and price schedule.
- 18. 90% payment will be made within 30 (Thirty) days of receipt, verification and acceptance of the complete materials along with bill, test certificate, guarantee certificate and other documents. Balance 10% will be released within 60 days of supply. However if a performance bank guarantee is received for 10% of the value of materials, the same amount will be released after due verification of the Bank Guarantee and acceptance of the complete materials at OCCL store.
- 19. Price escalation will not be allowed under any circumstances. The quoted rates will remain firm till issue of the purchase order.
- 20. The validity of the offer should be for a period of 120 (One hundred twenty) days from the date of opening of the tender.
- 21. The complete ordered quantity is to be supplied within 30 (thirty) days from the date of issue of the purchase order, failing which the order is liable for cancellation without assigning any reason thereof by the purchaser. In case of cancellation of the order the EMD will be forfeited.
