## SHORT QUOTATION CALL NOTICE No. OCC/LSGEP/ 05/22-23 Dated - 28.02.2023

Sealed quotations are invited from manufacturers / stockiest / dealers for "SUPPLY OF ELECTRICAL MATERIALS FOR LOWER SUKTEL GATE ERECTION PROJECT" as per detailed specification enclosed to be received up to 1.00 PM on 04.03.2023 and opened at 3.00 PM on the same date in presence of the quotationers or their authorized representative. The sealed covers should be clearly mentioned with quotation call notice No. & date of opening on the Top right hand of sealed cover positively.

- 1. Reputed manufacturers/ traders /Dealers having valid authentic certificate will be eligible to participate in the quotation for supply of reputed brand of Aluminum Armoured cables like Polycab etc. as per BOQ.
- Quotation should be submitted in sealed cover and subscribing in bold letters as "SUPPLY OF ELECTRICAL MATERIALS FOR LOWER SUKTEL GATE ERECTION PROJECT" and also date of opening of quotation. The name and address of the quotationer should not be written on cover.
- 3. The envelope superscribing in bold letters as ""SUPPLY OF ELECTRICAL MATERIALS FOR LOWER SUKTEL GATE ERECTION PROJECT"" should contain the following:
  - a. Attested copy of valid GST registration certificates. The quotationer will mention his GST Regd. No. in his quotation clearly without which the quotation will not be taken into consideration..
  - b. Attested copy of PAN Card.
  - c. Complete quotation document in original including terms and conditions, detailed specifications and price schedule duly signed on each page by the quotationer or his/their power of attorney holder. In case of power of attorney holder, an attested copy of power of attorney should be furnished.
  - d. Authorised distributorship/stockist/dealership certificate copy, if not a manufacturer

- 6. The undersigned will not be responsible for any kind of delay in receipt of quotations by the postal/courier authorities.
- 7. The materials will be guaranteed by the supplier against any defect for a period of 18 months from the date of supply or 12 months from the date of use, whichever is earlier. Guarantee certificate in this regard will accompany with supply of materials. If any defect is found in the materials within the guarantee period, the same will have to be replaced free of cost by the supplier.
- 8. The quotationer will quote their rates F.O.R. at Lower Suktel Gate Erection Project, Magurbeda, Balangir (Odisha) indicating separately the basic price, packing, forwarding, transportation, transit insurance, handling charges, taxes, duties, levies etc. strictly in the specifications and price schedule format in original. All columns and lines of the specification and price schedule should be filled in properly without leaving any thing blank. The details and rates of duties, taxes etc. should be indicated clearly in the specification and price schedule.

9. 100% payment will be made within 15 days of receipt, verification and acceptance of the complete materials along with bill, guarantee certificate and other documents.
