The quotation should be submitted in sealed outer cover subscribing in bold letters as “**Supply of Oxygen & DA Gas Cylinders for Repair & Renovation work of Radial Gates of both Indravati & Muran Dam of UIHEP**” and also date of opening of quotation. The name and address of the quotationer should not be written on outer cover. Only the name and address of the purchaser should be written on the outer cover.

2. The offer should contain the following copies:
 - i. Valid GST Regn. Certificate.
 - ii. Attested copy of PAN Card.
 - iii. Attested copies of purchase orders, credentials, certificates etc. in support of supply of similar items of magnitude and satisfactory performance thereof.
 - iv. The original terms & conditions, price schedule duly signed by the quotationer, without which their offer will not be considered.
3. The quotationer shall quote their rates for gas cylinders indicating separately the basic price per each inclusive of packing, forwarding, handling charges & GST etc. alongwith Security Deposit per cylinder strictly in the detailed specifications and price schedule format in original. All columns and lines of the price schedule should be filled in properly without leaving anything blank. The details and rates of duties, taxes and levies etc. should be indicated clearly in the price schedule.
4. If there will be a public holiday on the last date of sale of quotation document and receipt & opening of the quotations as specified above, the quotation document will be sold and quotations will be received & opened on the next working day at the same time and venue.
5. The tenderer should quote appropriate taxes with the offer.
6. In case of authorization to the authorized distributor / dealer to participate in the quotation / placing order; the manufacturer should quote the rates and to inspect / certify the genuineness of the industrial gases.
7. The rates and amounts should be quoted both in figures and words in the price schedule. Any correction or overwriting in the specification and price schedule should be duly certified by the quotationer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered.
8. Industrial Oxygen Cylinders, Dissolved Acetylene gas Cylinders should be delivered to the Consignee at go-down of the agency on returnable basis.
9. The supply of gas should be made in phased manner as per our requirement.
10. No detention charges for cylinders will be paid under any circumstances.

11. 100% payment will be released within 30 days against receipt of bill and other required documents after delivery & acceptance at OCCL Store.
12. In the event of any variation occurs due to hike in price of calcium carbide, enhancement of rate in D.A. Gas will be considered only on receipt of satisfactory documentary evidence.
13. In case any material is found defective and not replaced by the quotationer within a suitable time fixed by the Corporation without any extra cost. In this connection, the decision of the purchaser is final and binding on the quotationer.
14. Price escalation will not be allowed under any circumstances. The quoted rates will remain firm till execution of the purchase order.
15. The validity of the offer should be for a period of **365** (Three hundred sixty-five) days from the date of opening of the tender.
11. The complete ordered quantity is to be supplied within 07 (Seven) days from the date of issue of the purchase order, failing which the order is liable for cancellation without assigning any reason thereof by the purchaser. In case of any delay in supply of material beyond the delivery schedule whatever may be the reason, supplier shall be liable to pay L.D. @ 0.5% (Half percent) of the total order value per week of delay or part thereof subject to a maximum of 10% (Ten percent) of the total order value. Thereafter, the order may be cancelled with the discretion of the purchaser.
12. Conditional offers with deviations will not be accepted. Those, who do not agree to the terms and conditions regarding payments, delivery and others, need not quote.
13. The authority reserves the right to accept/reject any or all quotations without assigning any reason thereof.
14. Any dispute arising out of this tender or order thereof is to be settled in proper court under the jurisdiction of Odisha High Court at Cuttack or courts under the jurisdiction of Odisha High Court at Bhubaneswar only.
