- 10) The half gear half rigid coupling shall be guaranted by the tenderers for a period of 18 months from the date of supply or 12 months from the date of erection and use, whichever is earlier. Guarantee certificate in this regard shall accompany with supply.
- 11) Half gear half rigid coupling must be supplied strictly confirming to relevant details specifications and technical data along with the tender.
- Manufacturers test certificate of half gear half rigid coupling as per details specification and technical data must be provided along with supply. The test certificate of the couplings shall also be provided from a Govt. / govt. approved test laboratory along with supply of couplings. The purchaser is having the option to test the materials in any laboratory at the cost of the supplier and if the materials are not found in accordance with the specifications, the materials will be rejected. The half gear half rigid coupling shall be inspected by the authorized representative of the purchaser / client / third party appointed by OCCL. In case of any defect noticed during the guarantee period the same shall be replaced / rectified immediately by the manufacturer free of cost.

Balance 10% payment will be released after 18 months of supply or 12 months from the date of commissioning whichever is earlier. - 18) Price escalation will not be allowed under any circumstances. The quoted rates shall remain firm till execution of the work order.
