Reputed workshop owners having facility for machining of hydro mechanical structure of irrigation project at their workshop or similar item of similar magnitude earlier and satisfactorily accepted by the clients will be eligible to participate in the quotation. The copies of purchase orders, credentials, certificates etc. in support of similar work and satisfactory performance thereof will be furnished along with the quotation.
2. Quotation should be submitted in two bid system in two separate sealed covers and both will be submitted in a single sealed outer cover subscribing in bold letters as "**QUOTATION FOR MACHINING OF DRUM GEAR ( BY HOBGING MACHINE) FOR 65T HOIST OF LOWER SUKTEL IRRIGATION PROJECT**" and also date of opening of quotation. The name and address of the quotationer should not be written on outer cover. Only the name and address of the purchaser should be written on the outer cover.

9. The machining of wire rope drum from proof machining condition should be as per drawing, specifications and price schedule strictly conform to relevant standards of Bureau of Indian Standard (BIS).
10. The purchaser may increase / decrease the number of items to be machined in fully machined condition as quantified in detailed technical specification of the price schedule.
11. The machining will be guaranteed by the supplier against any defect for a period of 18 months from the date of delivery after machining or 12 months from the date of use, whichever is earlier. Guarantee certificate in this regard will accompany with delivery of materials after machining.
12. Pre-delivery inspection (P.D.I) before dispatch of the materials after machining will be made at the machining place of the workshop owner by the authorized representative of the purchaser / client / third party for which the workshop owner should intimate in writing for P.D.I. 10 days in advance regarding readiness for P.D.I.
13. The quotationer shall quote their rates for lifting of materials in proof machining condition from the works of M/s Mechanico (India), Howrah, West Bengal and supply of each item after final machining again at the workshop of M/s Mechanico (India) indicating separately the basic price, packing, forwarding, transportation, transit insurance, handling charges, taxes, duties, levies etc. strictly in the specifications and price schedule format in original. All columns and lines of the specification and price schedule should be filled in properly without leaving anything blank. The details and rates of duties, taxes etc. should be indicated clearly in the specification and price schedule.

18. The complete ordered quantity is to be supplied after machining within 10 (Ten) days from the date of issue of work order for machining, failing which the order is liable for cancellation without assigning any reason thereof by the purchaser.. In case of any delay in supply of material after machining beyond the delivery schedule whatever may the reason, workshop owner shall be liable to pay L.D. @ 0.5% (Half percent) of the total order value per week of delay or part thereof subject to a maximum of 5% (Five percent) of the total order value.
19. Conditional offers with deviations will not be accepted. Those, who do not agree to the terms and conditions regarding payments, delivery and others, need not quote.

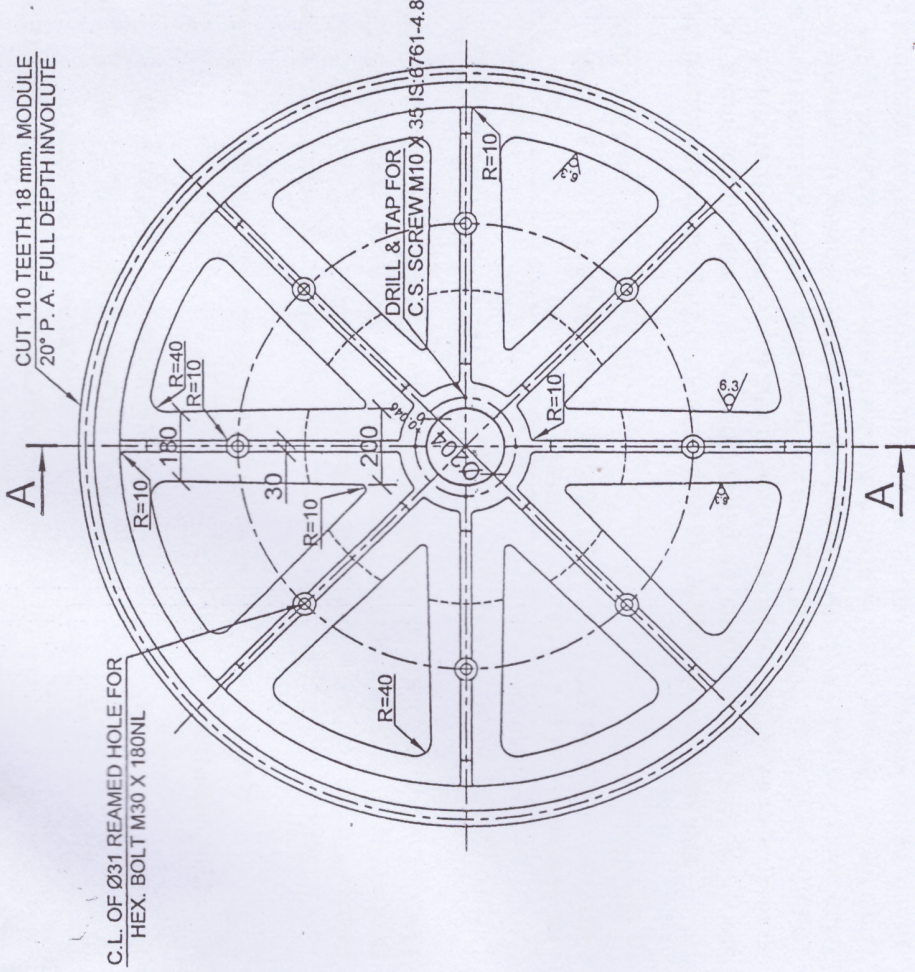

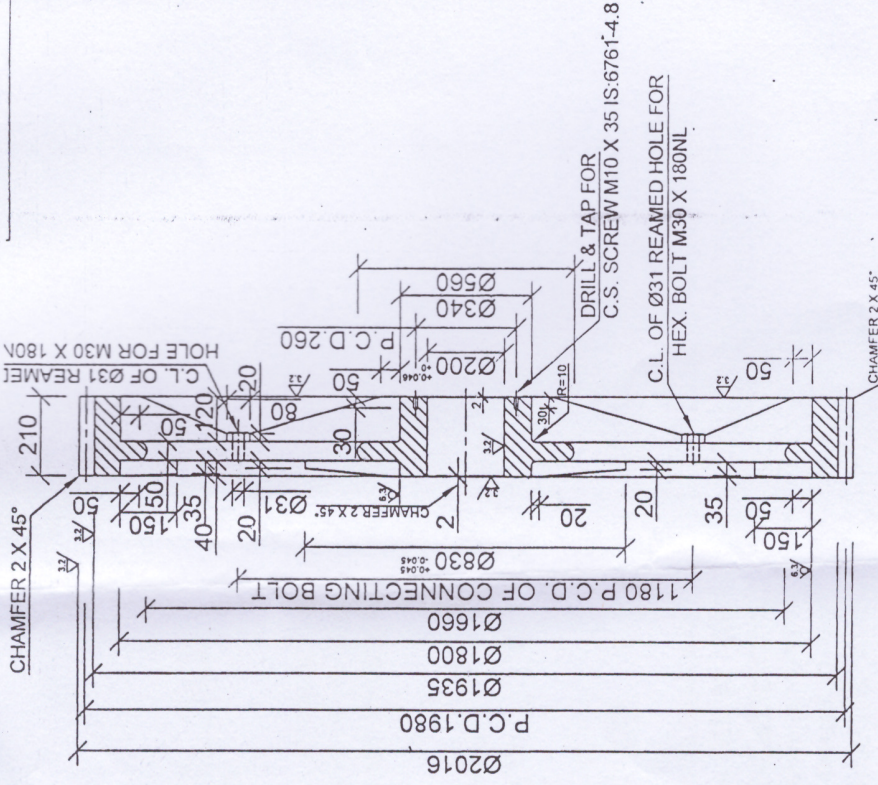
