- Original test certificate of materials confirming to relevant IS: specification and grade for physical property will be provided by the successful tenderer from Govt./Govt. approved testing laboratory along with supply of materials. The purchaser is having the option to test the materials in any laboratory at the cost of the supplier and if the materials are not found in accordance with the BIS specifications and size, the materials will be rejected.
- 12. The materials shall be inspected at the time of receipt at OCCL store, Central Workshop, Rasulgarh, Bhubaneswar. If the materials are not found in accordance with proper IS specifications and drawings, the same shall be out rightly rejected.
- 13. The materials will be guaranteed by the supplier against any defect for a period of 18 months from the date of supply or 12 months from the date of use, whichever is earlier. Guarantee certificate in this regard will accompany with supply of materials. If any defect is found in the materials within the guarantee period, the same will have to be replaced free of cost by the supplier within a suitable time fixed by the purchaser.
- 14. The tenderer will quote their rates F.O.R. Balance 10% will be released after 18 months of supply or 12 months from the date of commissioning whichever is earlier. However if a performance bank guarantee is received for 10% of the total basic cost, the same will be released within 60 days from the date of receipt of materials.
- 17. Price escalation will not be allowed under any circumstances. The quoted rates will remain firm till execution of the work order.
- 18. The validity of the offer should be for a period of 120 (One hundred twenty) days from the date of opening of the tender.
- 19. The complete ordered quantity is to be supplied within 60 (Sixty) days from the date of issue of the purchase order, failing which the order is liable for cancellation without assigning any reason thereof by the purchaser.
