The Tender notice shall also be available on OCCL website at <u>www.odishaconstruction.com</u>. Interested Agencies may obtain further information, if any, from the undersigned.
- 3. The quotations must be accompanied with EMD (Earnest Money Deposit) of the amount specified for the work in the table above in shape of Term Deposit Receipt (TDR) pledged in favour of Odisha Construction Corporation Limited/ Bank Guarantee in prescribed format in favour of Odisha Construction Corporation Ltd. Payable at Bhubaneswar and should be valid for minimum 90(Ninety) days from the date of opening of quotations.
- 4. The Quotations must be dropped in the Tender Drop Box specified for the work kept in the office of the General Manager (Civil), Odisha Construction Corporation Ltd., Central Zone, Plot No- 1143, Vinayak Nagar, Mahanadi Vihar, Cuttack 04 on or before 3.30 PM of date.12.03.2024 and will be opened at 4.00 PM onwards on the same day of receipt in the presence of the Agencies or their authorized representative, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the quotations as specified above, the quotation documents shall be received & opened on the next working day at the same time & venue.

5. Additional Performance Security shall be submitted by the Agency when the bid amount is less than the estimated cost put to tender. In such an event, only the successful Agency who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish an amount as stipulated below towards Additional Performance Security (APS) in shape of Term Deposit Receipt (TDR) pledged in favour of Odisha Construction Corporation Limited/ Bank Guarantee in prescribed format in favour of Odisha Construction Corporation Limited from any nationalized/scheduled bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by Odisha Construction Corporation Limited Magency shall be cancelled and further proceedings for blacklisting shall be initiated against the Agency.

- 6. Intending Agencies are required to furnish the following documents duly signed by the Agencies along with their tender.
  - (i) Copy of valid enlistment certificate as Agency issued by "OCCL"
  - (ii) E.M.D. in shape of TDR
  - (iii) Copy of valid GST Certificate
  - (iv) Copy of PAN card.
  - (v) Copy of No Relation certificate.
  - (vi) Undertaking to pay minimum wages.
  - (vii) Undertaking to pay royalty as per prevailing rate during the time of execution
  - (viii) Affidavit in support of genuineness of certificate
  - (ix) Complete tender document duly filled-in and signed on each page by the tenderer or his/their power of Attorney holder with date, full name, Designation, & Official Seal. In case of power of Attorney holder the copy of such delegation is to be enclosed with the tender documents.
- 7. The Quotation Notice No and the name of the work is to be mentioned on the envelope clearly & delivered in the tender box at office of the General Manager (Civil), Central Zone, Odisha Construction Corporation Ltd., Plot No:-1143, Vinayak Nagar, Mahanadi Vihar, Cuttack-4, Dist:-Cuttack (Odisha). The sealed quotation duly filled in properly must be signed by the

Agency in each & every page with a token of acceptance of terms, conditions, specifications as lay down in the Quotation.

- 8. The items of Bill of Quantity (BoQ) includes cost of materials, labour, conveyance, royalty, DMF, EMF, additional charges, incidental charges, cess, taxes and other charges required to complete the item in all respect as per the specification and direction of the Engineer-in-Charge. The rates of each items are excluding GST as applicable. The Job- Worker are to quote the % (percentage) excess or less or at par of the amount put to tender in the bill of quantity in the format enclosed with the tender document. If the percentage rate quoted by the Agency is less than 15% of the tendered amount then such a bid shall be rejected & the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the tendered cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all Agencies / their authorized representatives and the Senior Manager (Civil), Jajpur Group of Projects will remain present.
- 9. The Agency shall have to furnish an affidavit in support of the authenticity/ genuineness of the documents/certificates and credentials along with the quotation document. In case of production of forged document, the penalty shall be rejection of their tender and cancellation of their enlistment with the Corporation. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.
- 10. The quotation received will remain valid for 90 (Ninety) days from the last date of receipt of bid and the validity of bid can also be extended if agreed to by the Agency and OCCL.
- 11. The Agencies are to quote the % (Percentage) excess or less or at par of the amount put to tender (excluding GST) in the bill of quantity/price schedule in the format enclosed with the quotation document.
- The successful Agency shall have to execute work as per scope of work, relevant drawing, technical specification and terms and conditions of agreement and direction of the Engineerin-Charge.
- 13. If an agency participates in more than one work in this quotation and becomes lowest in more than one work the Authority reserves the right to award one or more work to them taking time and other factors into consideration.
- 14. The authority reserves the absolute right to accept or reject any or all tenders and to split up works to award to one or more Agencies without assigning any reason thereof.

15. Any dispute arising out of the above tender call notice shall be subject to Jurisdiction of Hon'ble High Court of Odisha at Cuttack and their sub-ordinate courts at Bhubaneswar only.
