1. This application booklet duly filled-in, signed and stamped on each page and complete in all respects with all enclosures, should be **submitted in original** to the Managing Director, Odisha Construction Corporation Ltd., Unit-8, Gopabandhu Nagar, Bhubaneswar - 751 012 (Odisha).
2. All documents submitted as enclosures with this booklet must be **signed by the applicant on each page** and the original documents should be produced for verification at the time of submission of the application booklet. Money Receipt towards cost of application form amounting to Rs.1,000.00 (if issued by hand) or Rs.1,100.00 (if issued by post) with applicable GST, as the case may be, must be enclosed in original. The applicants applying for Grade C-IV/M-IV/ELT/Associated Consultants category should deposit the non-refundable enlistment fees as mentioned against each category in data sheet and attach the photocopy of the Money Receipt with the booklet. The enlistment will be valid for a period of 3 years from the date of enlistment.
3. The Corporation will intimate applicants applying for Grade III and above categories as well as Grade-EHT separately to **deposit the non-refundable enlistment fees** after provisional selection. After payment of the non-refundable enlistment fee, the applicant will be enlisted as a Job-Worker/Piece-Worker of O.C.C Ltd. which will be valid for a period of 3 years from the date of enlistment.
4. 3(Three) Nos. of recently taken **passport size color photographs** duly self attested by the applicant (on the front side) must be submitted along with application.
5. Income Tax PAN, GSTIN, EPF Regn. No., Affidavits for Ownership/Proprietorship in case of Company/Firm etc. must be enclosed with application booklet.
6. For empanelment as an **Associated Consultant** of OCCL, Firms / Individuals having expertise in Design / Consultancy works can be empanelled in OCCL on submission of the following documents.

 - ii. Expertise / Credential documents
 - iii. Bio-data of technical Personnel
 - iv. Any other relevant document
7. For **Electrical Job-Workers**, attested copies of valid HT/LT License issued by the competent authority such as Chief Electrical Inspector etc. along with other required documents must be submitted along with application.
8. For existing Enlisted Job-Workers applying for **Up-gradation** to a higher Grade, the same process of selection will be followed and the applicant is required to apply with this Application Form & Booklet. The applicant should also enclose a copy of Enlistment Certificate issued earlier by OCCL along with other documents as required for the grade applied for. On selection, the applicant has to deposit the prescribed non-refundable enlistment fees as applicable for the grade allowed by OCCL and surrender the original enlistment certificate (issued earlier) before issue of the new Upgraded Enlistment Certificate.
9. **Renewal of enlistment** : Job-Worker/Associated Consultants enlisted for 3 years wishing to renew, will have to apply for Renewal (in form prescribed for Renewal) before expiry of the enlistment period on approval of which the required non-refundable renewal fee shall be deposited by the Job-Worker/ Associated Consultants to extend the validity of his enlistment for a further period of 3 years.
