1. Reputed workshop owner will be eligible to participate in the tender.
2. The tenderer will quote their rates F.O.R. OCCL, Central Workshop, Rasulgarh, Bhubaneswar (Odisha) inclusive of transportation of materials to be machined. Applicable taxes like GST, duties shall be quoted in the space provided in the price schedule. The tenderer who does not confirm to supply and take up the whole work at site, need not quote.
3. The quotation document must contain EMD@ 1% of the total quoted value along with the quotaition in shape of N.S.C. / Postal office Saving Bank Account / Postal Office Time Deposit Account / Kisan Vikas Patra / Bank Guarantee in favour of Odisha Construction Corporation limited, Bhubaneswar from any Nationalized Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar / e-Bank Guarantee executed on the National e-Governance Service Limited (NeSL) Digital Document Execution Portal/ Demand Draft / FD / TDR pledged in favour of the undersigned The quotations received without EMD will be out rightly rejected. 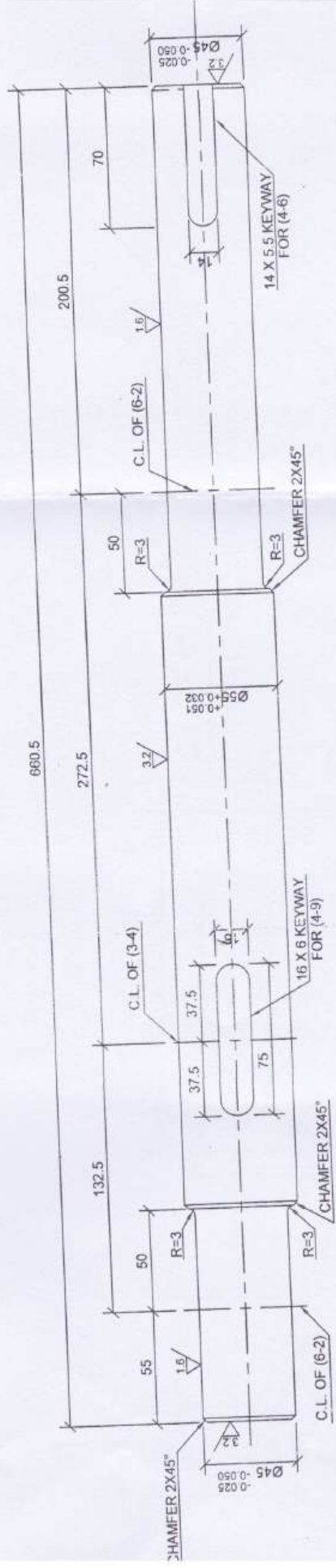

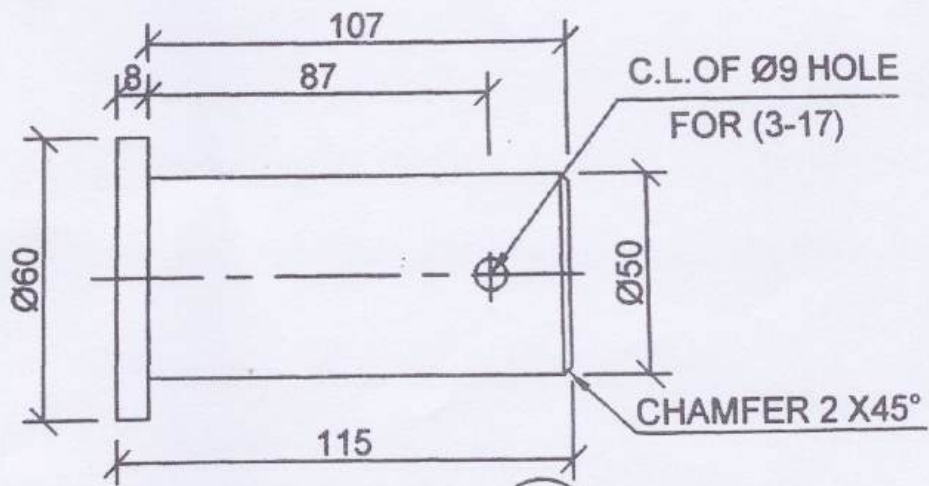

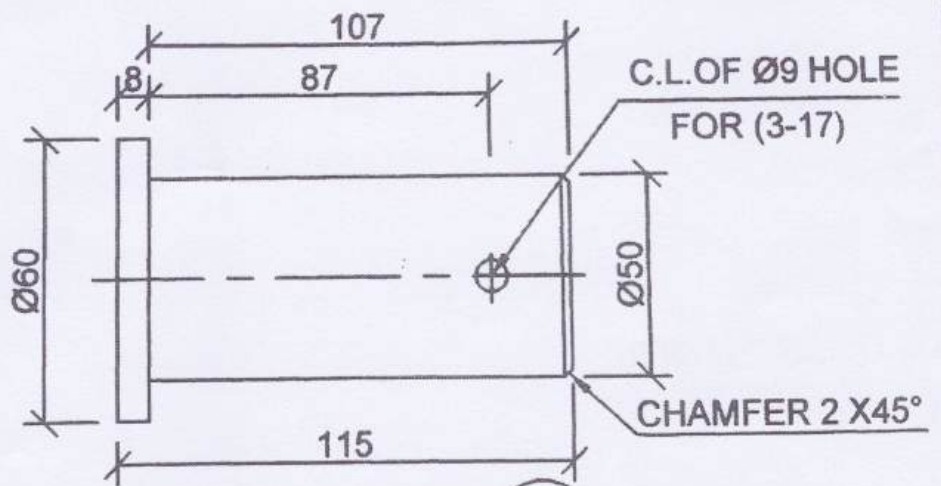
LIFTING PIN (3-16)
