**ELIGIBILITY & PRE-QUALIFICATION CRITERIA**



1. **Pre-Qualification Criteria:**

Interested agencies/firms should provide explicit information demonstrating the requisite qualification and relevant experience to perform the Special Audit of the specified work. Each bidder will be assessed based on the following pre-qualification criteria. The bidder is required to produce the copies of the required supportive documents / information as part of their EOI failing which the EOI will not be considered for short-listing.

**SUBMISSION OF PROPOSALS**

- (i) The agency/Firm shall upload its proposal in complete shape along-with the above stated documentary evidence and undertakings as required in Prescribed Annexure.
- (ii) Only those who fulfill all the eligibility criteria are eligible to participate in the EoI. The agency/Firm are not barred from producing any additional evidences or testimonials other than the ones asked for in this EoI which may be relevant.
- (iii) The offer for EoI as per this document shall be valid for a period of 90 days from date of submission which may be extended further if required, at the discretion of OCC Ltd.
- (iv) Agency/Firm shall bear all costs associated with preparation and submission of their proposals to the Head Office, Odisha Construction Corporation through Speed Post/Registered Post. Any deviation from the prescribed Forms and Annexure will entail the agency/firm for disqualification. The agency/firm should ensure that all the Forms and Annexure should be serially numbered and all pages duly signed by the Competent Authority.

**EVALUATION PROCESS (Technical Bid):**

- (v) EoIs shall be screened by Evaluation Committee of OCC Ltd. as per eligibility criteria and based on the documents submitted as listed out.

- (i) The Evaluation Committee shall shortlist a maximum of Top Three Agency/Firm (in case the number of Eligible Proposers are less than three, all will be shortlisted) based on their presentations as also taking into consideration the past experience of handling similar kind of projects, strength and qualification of their manpower of the Proposer, financial strength, Completion of special audit etc. The decision of the Evaluation Committee shall be final in this regard.
- (ii) OCC Ltd Will take up references and reserves the right to pay due heed to the agency/firm's performance elsewhere and any past experience with OCC.
- (iii) Shortlisted Agency/Firm will be issued Bid Documents containing detailed Scope of work/ Terms of Reference, deliverables, payment terms, other terms and conditions etc. and have to submit their Bid in a sealed envelope as per the procedure, details, formats furnished thereupon.

No payment other than the quoted/negotiated amount shall be made to the agency/firm. GST as applicable shall be paid extra to the agency/Firm on production of GST Invoice.
- (viii) The shortlisted qualified agency/Firm whose rate shall be found lowest and reasonable shall be awarded with the above assignment.
