“SUPPLY OF WIRE ROPES SLING FOR CENTRAL WORKSHOP, RASULGARH, BHUBANESWAR”

1. The firm should furnish technical literature and catalogues in support of specifications of Socketed Wire Ropes conforming to relevant IS: in line with technical specification and notes mentioned in the drawing and specification in the price schedule format.
2. The tender should be submitted in two bid system in two separate sealed covers and both will be submitted in a single sealed outer cover subscribing in bold letters as **“SUPPLY OF WIRE ROPES SLING FOR CENTRAL WORKSHOP, RASULGARH, BHUBANESWAR”** and also date of opening of quotation. The name and address of the quotationer should not be written on outer cover. Only the name and address of the purchaser should be written on the outer cover.
3. The tenderer should submit Earnest Money Deposit (EMD) @ 1(One)% of the total quoted value along with the tender in shape of N.S.C. / Postal office TDR / Bank Time Deposit Account / Kisan Vikas Patra / Bank Guarantee / Demand draft in favour of Odisha Construction Corporation limited, Bhubaneswar from any Nationalized Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar / e-Bank Guarantee executed on the National e-Governance Service Limited (NeSL) Digital Document Execution Portal/ FD / TDR pledged in favour of the undersigned.  - iv. Attested copies of purchase orders, credentials, certificates etc. in support of supply of similar items of magnitude and satisfactory performance thereof.
 - v. The original terms & conditions, price schedule duly signed by the quotationer, without which their offer will not be considered .

6. The tenderer who will participate through email (gmcwsoccltender@gmail.com), must upload all the self attested technical bid documents in one Enclosure-1 and Price schedule in another Enclosure-2. The tender (participated through e-mail) will scan the tender & EMD cost document / relevant financial documents and upload the same along with tender document in Enclosure-1. Subject of the Email should be **“TENDER FOR SUPPLY OF WIRE ROPES SLING FOR CENTRAL WORKSHOP, RASULGARH, BHUBANESWAR”**. Original copy of tender and EMD cost must submitted to the undersigned within 05(five) days of opening of tender, otherwise bid shall be rejected and the bidder will be debarred from participation in any future tender

The tender will be received upto **3.00 P.M.** on **21.12.2024** and will be opened in the office of the undersigned on the same day at **4.00 P.M.** in presence of your authorized representative, if so desire. If there will be a public holiday on the last date of sale of tender document and receipt & opening of the tenders, the tender document will be sold and tenders will be received & opened on the next working day at the same time and venue.
8. The undersigned will not be responsible for any kind of delay in receipt of offers by the postal/ courier authorities.
9. The first envelope will be opened on **21.12.2024** at **4.00 P.M.** first. Then the documents in the first envelope submitted by the firm will be scrutinized preliminarily on the spot. The second envelope of the valid eligible firm after preliminary scrutiny of the documents in the first envelope will be opened on the same day immediately subject to fulfilling the requirements mentioned in the tender schedule.
10. Test certificates on wire sling of manufacture must be sent to us.
11. The wire rope sling should strictly confirm to relevant ISI Code and the reputed manufacturer must be ISO certified. Physical and chemical test analysis with proof load test of each wire rope sling and test report be handed over to the consignee.
12. The wire rope sling shall be guaranteed for a period of 18 months from the date of supply or 12 months from the date of use, whichever is earlier. Guarantee certificate in this regard will accompany with supply of materials.
13. The firm shall quote their rates F.O.R. OCCL Store, Central Workshop, Rasulgarh, Bhubaneswar indicating separately the basic price per each, packing, forwarding, transportation, transit insurance, handling charges, taxes including GST. however taxes should be indicated separately besides the basic price per each in the tender paper strictly in the detailed specifications and price schedule format in original. All columns and lines of the price schedule should be filled in properly without leaving any thing blank. The offer of the firm shall not be considered, if their rates are not quoted F.O.R. Odisha Construction Corporation Ltd, Central Workshop, Rasulgarh, Bhubaneswar-10, Odisha.
14. The manufacturer's test certificate in original will have to be furnished by the successful tenderer/ supplier for individual item. The purchaser is having the option to test the materials in any laboratory at the cost of the supplier and if the materials are not found in accordance with the BIS specifications and grade, the materials will be rejected.
15. Pre-delivery inspection (P.D.I) before dispatch of the materials will be made at the manufacturer's works by the authorized representative of the purchaser / client / third party appointed by the purchaser for which the manufacturer should intimate in writing for P.D.I. 10 days in advance regarding readiness for P.D.I. Load testing shall be done in presence of the authorized representative of the purchaser before dispatch.
16. The tenderer should quote appropriate taxes with the offer.

17. The rates should be quoted per each wire rope sling in the line with detail technical specification, materials and notes mentioned in the drawing.
18. The rates and amounts should be quoted both in figures and words in the price schedule. Any correction or overwriting in the specification and price schedule should be duly certified by the quotationer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered. In case of any mismatch in rates and amount, the rate will be considered.
19. 90% payment will be made within 30 (thirty) days after receipt, verification and acceptance of the complete materials along with bill, test certificate, guarantee certificate and other documents. Balance 10% shall be released after 18 months of supply or 12 months from the date of commissioning whichever is earlier. However if a performance bank guarantee is received for 10% of the total basic cost, the same will be released within 60 days from the date of receipt of materials. No advance payment shall be made under any circumstances.
20. Price escalation will not be allowed under any circumstances. The quoted rates will remain firm till execution of the purchase order.
21. The validity of the offer should be for a period of 120 days from the date of opening of the quotation.
22. The complete ordered quantity is to be supplied by the successful quotationer within 30 (Thirty) days from the date of issue of the purchase order, failing which the order is liable for cancellation without assigning any reason thereof by the purchaser. In case of cancellation of the order the EMD will be forfeited. In case of any delay in supply of material beyond the delivery schedule whatever may the reason, supplier shall be liable to pay L.D. @ 0.5% (Half percent) of the total order value per week of delay or part thereof subject to a maximum of 10% (Ten percent) of the total order value.
