- 12) The materials should be supplied in assembled conditions by successful tenderer / supplier as per required drawings which can be collected from the office of the Senior Manager (Mech.)-I, Central Workshop and should strictly conform to relevant standards of Bureau of Indian Standard (BIS) as mentioned .
- 13) All structural steel materials required as per drawing should be of make SAIL / TATA / JINDAL. Manufacturer test certificate of steel materials should be furnished by bidder.
- 14) The materials will be guaranteed by the supplier against any defect for a period of 18 months from the date of supply or 12 months from the date of use, whichever is earlier. Guarantee certificate in this regard will accompany with supply of materials. If any defect is found in the materials within the guarantee period, the same will have to be replaced free of cost by the supplier.

- 19) The rates and amounts should be quoted both in figures and words in the price schedule. Any correction or overwriting in the specification and price schedule should be duly certified by the tenderer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered. In case of any mismatch in rates and amount, the rate will be considered.
- 20) 90% payment will be made within 30 days of receipt, verification and acceptance of the complete materials along with bill, test certificate, guarantee certificate and other documents. Balance 10% will be released after 18 months of supply or 12 months from the date of commissioning whichever is earlier. However if a performance bank guarantee is received for 10% of the value of materials, the same will be released within 60 days from the date of receipt of materials.
- 21) The purchaser reserves the right to forfeit and encash the performance bank guarantee / EMD in full in case any casting is found defective and not replaced by the tenderer/supplier within a suitable time fixed by the corporation. 
