6. The Job-Worker preferably should have executed similar nature of work in the past. Work order and work completion certificate from the existing agency must be furnished with the tender. However the decision of OCCL regarding qualifying criteria of the Job-Worker is final and binding on the Job-Worker.
7. Intending Job-Workers are required to furnish the following documents along with their tender.

The stamp paper to be in the name of the Job-Worker who is issuing the Power of Attorney

The tender (participated through e-mail) will scan the tender & EMD cost document / relevant financial documents and upload the same along with tender document in Enclosure. Original copy of tender and EMD cost must submitted to the undersigned within 05(five) days of opening of tender, otherwise bid shall be rejected and the bidder will be debarred from participation in any future tender.

The successful Job-Worker shall have to execute the work as per scope of work, methodology of work, technical specifications & price schedule as per direction of Engineer-in-charge and terms & conditions of agreement. The successful Job-Worker is required to furnish necessary labour license, issued by competent authority before commencement of the work.
13. Quantity in the tender / Bill of quantity / price schedule may increase or decrease as per drawing / requirement during execution of work as per direction of the Engineer-in-charge and payment shall be made accordingly.
