The Bidder (Job worker) have to deposit the non refundable cost of tender paper specified for the work in the table as above in shape of Demand Draft from any Nationalized / Scheduled Bank operative in Odisha, payable at Bhubaneswar in favour of Odisha Construction Corporation Ltd. Interested Bidders may obtain further information, if any, from the undersigned i.e O/o the Senior Manager (Civil), OCC Ltd., Jajpur Group of Projects, Jajpur.

3. The tender must be submitted at the office of the Senior Manager (Civil), OCC Ltd., Jajpur Group of Projects, Jajpur on or before 02.00 PM on dated. 30.07.2025 and will be opened in the office of the Senior Manager (Civil), Jajpur Group of Projects, Jajpur on Dt. 30.07.2025 at 03.00 PM in presence of bidders or their authorized representatives. If there will be a public holiday on the last date of receipt & opening of the tenders as specified above, the tender documents shall be received & opened on the next working day at the same time & venue.

4. Intending bidders are required to furnish the following documents duly signed by the bidders along with their tender.

- Copy of valid enlistment certificate as Bidder issued by "OCCL".
- E.M.D. in shape of TDR.
- Copy of valid GST Certificate
- Copy of PAN card
- Copy of No Relation certificate.
- Undertaking to pay minimum wages
- Undertaking to pay royalty as per prevailing rate during the time of execution.

- (viii) Necessary affidavit for execution of Electrical Works through registered/certified Electrical Agency/Contractor.
- (ix) Affidavit in support of genuineness of certificate.
- (x) Complete tender document duly filled-in and signed on each page by the tenderer or his/their power of Attorney holder with date, full name, Designation, & Official Seal. In case of power of Attorney holder the copy of such delegation is to be enclosed with the tender documents.
- (xi) Income Tax Clearance Certificate.

5. The tender (sealed cover) must be super scribed – "Tender Call Notice No. 01/2025-26/SM/OCCL/JGP, DT. 21.07.2025" and name of work on the envelope clearly and dropped in the tender box kept in the Office of Senior Manager (Civil), Jajpur Group of Projects, Jajpur. The sealed tender document duly filled in properly must be signed by the bidder in each and every page with a token of acceptance of terms, conditions, specifications as laid down in the tender document. All other credentials/documents submitted by the bidder along with this tender document must also be signed by him in each and every page.

6. Additional Performance Security shall be submitted by the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish an amount as stipulated below towards Additional Performance Security (APS) in shape of Demand Draft in favour of Odisha Construction Corporation Ltd." payable at Bhubaneswar / Term Deposit Receipt (TDR) pledged in favour of Odisha Construction Corporation Limited/ Bank Guarantee in prescribed format in favour of Odisha Construction Corporation Limited from any nationalized/scheduled bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by Odisha Construction Corporation Limited (by email) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and further proceedings for blacklisting shall be initiated against the bidder.

7. The bidder shall have to furnish an affidavit in support of the authenticity/ genuineness of the documents/certificates and credentials along with the tender document. In case of production of forged document, the penalty shall be rejection of their tender and cancellation of their enlistment with the

Corporation. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.

8. The tender received will remain valid for 90 (Ninety) days from the date of receipt of tender and the validity of tender can also be extended if agreed to by the bidder and OCCL.

9. The Job- Worker are to quote the %(percentage) excess or less or at par of the amount put to tender in the bill of quantity in the format enclosed with the tender document. For evaluation, the amount quoted in words shall be taken, if there is any difference in figure and words in tender document. If the amount quoted by the bidder is less than 15% of the tendered amount then such a bid shall be rejected & the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the tendered cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders / their authorized representatives and the Senior Manager (Civil) will remain present.



The J/W (successful Bidder) has to submit work programme before drawal of Agreement.

11. The authority reserves the absolute right to accept or reject any or all tender and to split up work to award one or more Job-workers without assigning any reason thereof.

12. Any dispute arising out of the above tender call notice shall be subject to Jurisdiction of Hon'ble High Court of Odisha at Cuttack and their sub-ordinate courts at Bhubaneswar only.
