The quotations must be accompanied with Earnest Money Deposit of the amount specified for the work in the table above in shape of demand draft of any nationalized bank /Scheduled bank drawn in favour of "Odisha Construction Corporation Ltd." payable at **Baripada/ Bhubaneswar**. The demand draft should be valid for 90 (Ninety) days from the date of opening of quotation.

The quotation must be submitted at Project office at Laxmiposi, Baripada on or before **1.00 PM** on **26.08.2025** and will be opened on **26.08.2025** at Project office at Laxmiposi, Baripada at **3.30 PM** in the presence of the bidders, who may like to be present. If there will be a public holiday on the last date of sale of quotation document and receipt & opening of the quotations as specified above, the quotation document will be sold and quotations will be received & opened on the next working day at the same time and venue
6. Intending quotationer are required to furnish the following documents along with their quotations to be eligible to participate in the quotation.

7. The quotation received will remain valid for 30 (Thirty) days from the date of receipt of quotation and the validity of quotation can also be extended if agreed to by the quotationer and OCCL.
8. The authority reserves the absolute right to accept or reject any or all quotations and to split up works to award to one or more Associated Consultants without assigning any reason thereof.
9. The Associated Consultants are also required to submit their technical offer with detail of man power, infrastructure and work plan along with the financial offer as per the scope of work.
10. The Associated Consultant is also required to attend the meeting with no additional cost at various levels on behalf of OCCL for clearance of the work activities & also to comply any suggestions / comments made for the work.
11. The Associated Consultants are to quote their fees including all taxes as admissible excluding GST which shall be paid extra as per prevailing rules.
12. The Quotation is required to submit the break-up fees quoted according to items-wise activities including supporting rate justification.
13. The Associated Consultant shall have to carry out the work as per conditions of the agreement and shall also be responsible for accuracy of the work submitted by them irrespective of the fact whether the same has been examined and accepted by the employer / Department or not.


