Industrial leather shoes with socks must be supplied strictly confirming to IS:15298 (Part-2) 2002 or latest specifications as mentioned in the detailed specification in the price schedule format with the quotation document. The quotationer should furnish the sample of shoe and socks with detail specification and leaflet of shoes to be supplied against their quoted rate.
2. The quotationer shall quote rates F.O.R. OCC Ltd, Central Workshop, Rasulgarh, Bhubaneswar-751010 (Odisha) inclusive of P & F, Transportation, handling charges etc. where taxes should be shown separately. The rates shall be quoted strictly as per Pair basis only on the price schedule format. The quotationer should furnish sample piece along with the offer.
3. Complete quotation schedule in original should be duly filled and signed on each page and furnished along with quotation. Quotations received without the original price schedule will be out rightly rejected.
4. The quoted rate shall be valid for a period of 120 days from the date of opening of the quotation.
5. The successful quotationer has to take foot measurement size of the required quantity before supply & supply should be executed accordingly.
6. The industrial shoes must be warranted against sole pasting, stitching and any manufacturing defects for a minimum period of 12 (twelve) months from the date of supply. In case of any defects found on the shoes during the warrantee period, the same shall be replaced free of cost by the supplier. Warrantee Certificate in this regard must be accompanied with supply of shoes.
7. 90% payment shall be made after receipt, verification and acceptance of complete materials at OCCL Store along with required guarantee certificate. Balance 10% shall be paid within 30 days from the date of supply of materials.
8. Price escalation will not be allowed under any circumstances. The quoted rates shall be firm till execution of the entire order.
9. Delivery of the complete ordered quantity against purchase order shall be made within 30 days from the date of issue of the purchase order. However the requirement may vary $\pm 10\%$ at the time of placing purchase order.
10. No advance payment shall be made under any circumstances. Conditional quotation with deviation shall not be accepted.
11. The purchaser reserves the right to accept/reject any or all quotations without assigning any reason thereof.
