1. The tender should be submitted in sealed outer cover subscribing in bold letters as **“SUPPLY OF D. ACETYLENE GASES, INDUSTRIAL OXYGEN GASES & CO<sub>2</sub> REQUIRED FOR CENTRAL WORKSHOP, RASULGARH, BHUBANESWAR”** and also date of opening of tender. The name and address of the tenderer should not be written on outer cover. Only the name and address of the purchaser should be written on the outer cover.
2. The offer should contain the following copies:
  - i. Valid GST Regn. certificate.
  - ii. Attested copy of PAN Card.
  - iii. Attested copies of purchase orders, credentials, certificates etc. in support of supply of similar items of magnitude and satisfactory performance thereof.
  - iv. The original terms & conditions, price schedule duly signed by the tenderer, without which their offer will not be considered .
3. The tenderer will quote their rates F.O.R. OCCL Store, Central Workshop, Rasulgarh, Bhubaneswar indicating separately the basic price per each inclusive of packing, forwarding, transportation, transit insurance and handling charges & GST, duties, levies etc. strictly in the detailed specifications and price schedule format in original. All columns and lines of the price schedule should be filled in properly without leaving anything blank. 7. The tenderer should quote appropriate taxes with the offer.
8. The rates and amounts should be quoted both in figures and words in the price schedule. Any correction or overwriting in the specification and price schedule should be duly certified by the tenderer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered. In case of any mismatch in rates and amount, the rate will be considered.
9. D.A. Gas & Industrial gas should be delivered to the Consignee at OCCL Store, Central Workshop, Rasulgarh, Bhubaneswar-10 in Cylinders on returnable basis.
10. The supply of gas should be made in phased manner as per our requirement.
11. No detention charges for cylinders will be paid under any circumstances for a period of 01 (One) month from the date of delivery of the particular cylinder / cylinders.
12. 100% payment will be released within 30 days against receipt of bill and other required documents after delivery & acceptance at OCCL Store.
13. In the event of any variation occurs due to hike in price of calcium carbide, enhancement of rate in DA Gas & Industrial Gas will be considered only on receipt of satisfactory documentary evidence.
14. Purchase order may be cancelled in case any material is found defective and not replaced by the tenderer within a suitable time fixed by the Corporation without any extra cost. In this connection, the decision of the purchaser is final and binding on the tenderer.
15. Price escalation will not be allowed under any other circumstances except Sl. No.13. The quoted rates will remain firm till execution of the purchase order.
15. The validity of the offer should be for a period of 180( One hundred eighty) days from the date of issue of purchase order.
16. The complete ordered quantity is to be supplied within 07 (Seven) days from the date of issue of the purchase order, failing which the order is liable for cancellation without assigning any reason thereof by the purchaser. In case of any delay in supply of material beyond the delivery schedule whatever may the reason, supplier shall be liable to pay L.D. @ 0.5% (Half percent) of the total order value per week of delay or part thereof subject to a maximum of 5% (Five percent) of the total order value. Thereafter, the order may be cancelled with the discretion of the purchaser.
17. Conditional offers with deviations will not be accepted. Those, who do not agree to the terms and regarding payments, delivery and others, need not quote.
18. The authority reserves the right to accept/reject any or all tenders without assigning any reason thereof.
